TNR PROCESS & SERVICES PROVIDED

- The cat(s) listed above will be humanely trapped and transported to Purr Heaven Sanctuary prior to their veterinary appointment.
- On their scheduled appointment day, the cat(s) will be transported to a veterinary clinic for the following services:
 - Spay or neuter surgery
 - Ear tipping (for identification as a sterilized community cat)
 - Rabies vaccination
- The cat(s) will be returned to the original property after recovery.
- Purr Heaven Sanctuary does not re-home cats as part of this program.
- All kittens must be eating cat food and old enough to be taken from property (approximately 8 weeks old, 2.5 to 3 pounds) and returned to property. We do not take kittens to adopt out but can refer you to other rescues while you foster the kittens. All adult cats and kittens are to be returned and cared for after TNR.

SURGICAL RISK & HEALTH DISCLOSURE

- The cat(s) will undergo surgical procedures which carry inherent risks, including complications, injury, or death.
- The health history and condition of feral or free-roaming cats are often unknown, increasing risk.
- Purr Heaven Sanctuary and its veterinary partners cannot guarantee outcomes.

TRANSPORT & TEMPORARY HOLDING CONSENT

- The cat(s) may be temporarily housed at Purr Heaven Sanctuary before and/or after their appointment for safe transport and recovery.
- Length of stay may vary depending on scheduling and recovery needs and is only temporary.

LIABILITY WAIVER & MUTUAL RELEASE

- Caregiver agrees not to hold Purr Heaven Sanctuary, its volunteers, or veterinary providers responsible for outcomes including illness, injury, or death, except in cases of gross negligence.
- Purr Heaven Sanctuary agrees not to hold the caregiver/property owner responsible for injuries or damages incurred during trapping, transport, or return.

RETURN AGREEMENT

The cat(s) will be returned to the property listed above after surgery and recovery, and permission is granted for their return.
